Executive Order

The Anti-Corruption Commission in exercise of the powers conferred upon it by Section 38 (8) and Section 171 of the Anti-Corruption Act of Bhutan 2011 hereby revises the declaration period for filing of Asset Declaration from February-March as prescribed in the Asset Declaration Rules 2017 to **March-April** hereafter.

The revision was done mainly for seamless integration of the Asset Declaration (AD) System and Revenue Administration Management Information System (RAMIS) that is, annual Asset Declaration to follow the tax filing period so that the AD System can fetch data from RAMIS after the declarant has filed the Personal Income Tax (PIT) prior to AD filing.

The revised declaration time will come into effect from March 2022.
