2. The quotation should reach the Administration & Finance Division, Anti-Corruption Commission, Thimphu on **16th March, 2017 before 10:00 AM.**
3. Bidders are requested to mention the name of the airline & submit confirmed itineraries.
4. The availability of seats at the time of travel should be confirmed before submitting the quotation.
5. Quotations without Bid security and without sealed envelope will be rejected.
6. The validation of fares and availability of seats should be as per the details mentioned above.
7. The bidders shall submit an EMD of Nu. 12,000/- (Twelve thousand) only drawn in favor of the Head, Secretariat Services ACC, Thimphu, in the form of demand draft/cash warrant.
8. The bidders shall enclose copies of valid trade license, tax clearance certificate and power of attorney wherever applicable.
9. No Cancellation charges shall be applicable unless the tickets have been purchased by the client (ACC).
10. The travel/ticketing agents should only quote full fare of the ticket. In the event, if the agent quotes excursion fare, the client (ACC) shall forfeit 10% as a performance security from the amount payable to the agent.
11. Any other conditions or policies such as “**non refundable**”, “**non transferable**” and “**charges for date change, name**” etc, with specific time line should be clearly mentioned.
