1. Quotation for purchase and issuance of air ticket for business and economy class is hereby invited for the following routes:

2. The quotation should reach the Administration & Finance Division, Anti-Corruption Commission, Thimphu on **24<sup>th</sup> February, 2016 before 10:30 AM.**
3. Bidders are requested to mention the name of the air line & submit confirmed itineraries.
4. The availability of seats at the time of travel should be confirmed before submitting the quotation.
5. Quotations without Bid security and without sealed envelope will be rejected.
6. The validation of fares and availability of seats should be as per the details mentioned above.
7. The bidders shall submit an EMD of Nu. 12,000/- (Twelve thousand) only drawn in favor of the Commissioner, ACC, Thimphu, in the form of cheque/draft/cash.
8. The bidders shall enclose copies of valid trade license.
9. No Cancellation charges shall be applicable unless the tickets have been purchased by the client (ACC).
10. The travel/ticketing agents shall be required to refund the difference of cost should an agent charge the full fare but issue an excursion ticket. Any other conditions such as "**non refundable**", "**non transferable**" and "**charges for date change**" etc, with specific time line should be clearly mentioned.
11. Lowest Evaluated Bidder who receives the award shall issue the tickets and in case of withdrawal, the EMD shall be forfeited by the procuring agency and the second lowest evaluated bidder shall be awarded the ticketing order. However, the differential amount shall be borne by the lowest evaluated bidder in case of withdrawal.
12. Payment shall be made only after the travel has been performed.
13. Travel/Ticketing agents may enclose separate itinerary indicating other details such as airline and flight number.
14. Unconditional quotations like an increase of fares or change of airlines at the time travel are not accepted.
