### Quotation for Vehicle Hire

Sealed quotations are invited for hire of 15 vehicle (Hilux or Bolero) with 4WD for National Integrity Assessment (NIA) data collection scheduled from 26<sup>th</sup> December 2016-23<sup>rd</sup> January 2017. The quotation should be submitted along with earnest money of Nu.25000.00 (Ngultrum Twenty five thousand only), in the form of Demand Draft or Cash Warrant in Favour of Offgt. Chief, Secretariat Services, Anti-Corruption Commission, Thimphu. Tender without earnest money shall be rejected. Earnest money shall be returned on finalization and award of contract.

#### **Terms & Conditions:**

1. Year of Manufacture: 2010 or Later
2. Insurance: Comprehensive. In case of Third party insurance, all mishaps will be fully at Owner's risk.
3. Condition of Vehicle: Should be in good condition to ply even on feeder and farm roads.
4. Driver: Experienced Driver & should not indulge in drugs/Alcohol/ Gambling practices
5. The cost of fuel, driver's salary, maintenance or anything pertaining to the vehicle should be met by the owner.
6. A KM log sheet shall be controlled & verified by the officer on duty. The vehicle shall also be used beyond normal working hours to facilitate the transportation of enumerators.
7. During the hiring period, if vehicle breaks down, the owner should provide replacement immediately, failing which, the difference in the hire charge for another vehicle will have to be borne by the owner.
8. These 15 vehicles will be hired for about 28days from 26<sup>th</sup> December 2016-23<sup>rd</sup> January 2017.
9. The payment shall be made at end of contract and no advance shall be provided. The amount equivalent to 5% TDS on the bill for hire shall be levied as per the rule.
10. A formal contract shall be signed between Lessor and Lessee after evaluation of bids. The Lessor shall provide 10% of contract amount or lump sum as performance security which shall be returned after the completion of contract.
11. The rates shall be valid till end of February 2017.
