Executive Order

The Anti-Corruption Commission in exercise of the powers conferred by Sections 40 (3) and 171 of the Anti-Corruption Act of Bhutan, hereby frames and adopts the Debarment Rules 2019. The adoption has been done in close consultation with the relevant stakeholders. The Rules are part of the overall Anti-Corruption strategy to promote integrity, transparency and accountability in the public agency's contractual transactions.

This Rule shall come into force from the day of issuances of this order.
