Prohibition Order

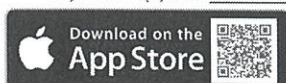
In exercise of power conferred under § 24 (1) of the Anti-Corruption Act of Bhutan (ACAB) 2011, the Anti-Corruption Commission (the Commission) hereby prohibit the following individuals or business entities from entering into contractual relationship with public agencies upon finding *prima facie* case of corruption, with immediate effect:
